Remote Online Notary (RON) Fees

MINIMUM RON SESSION TOTAL FEE is \$100. This includes the Document Fee plus RONSP services fees required to communicate, electronically prepare documents, & conduct a Zoom, WhatsApp, Whereby or Face Time meeting.

Document fee \$25 per document (US Citizen or Foreign Citizen)

When counting documents, Count ALL Documents, NOT ONLY the documents requiring notarization. Florida Statute fees for Remote Notarization is per document, not per notary stamp. All documents received must require a signature; initial; witness signature; and/or Notary signature/stamp.

\$0 One USA Citizen Signer. Each Additional USA Citizen Signer \$25 Up to 20 signers.

Includes USA Driver's License or USA Passport Knowledge-based authentication.

\$50 per Foreign Citizen Signer.

Additional Foreign Citizen Signer (\$50). Up to 20 signers.

Includes International Passport Biometrics ID Verification. (International Identification must be a Passport. Mexican and Canadian Citizens Driver's License are acceptable Foreign Citizen Identification).

\$100 Form 692 F.S. – Conveyances to Foreign Entities. One Signer.

Includes USA Driver's License or USA Passport Knowledge-based authentication or International Passport Biometrics ID Verification. Additional Signer on same document (\$25). Up to 20 signers per document.

\$75 per Verified, Disinterested Witness.

Only our verified, disinterested witnesses allowed on the video call per \$100,000 Errors & Omission Insurance Guidelines. (\$0) Remote Notary does not charge to be one of the witnesses. (\$25) Verification Affidavit per Title Insurance Fraud Polices.

\$250 Florida Seller Packet. One Signer. One Witness.

The entire seller packet (ALTA, Deed, Disbursement, FIRPTA, Closing Affidavit, Bill of Sale, etc) One Signer (additional signers \$25). Includes One Witness (additional witness \$75).
